4.0 **Physical Measurement (PMT) Standards and Medical Standards:** Candidates must ensure that they fulfill the prescribed PMT and Medical Standards for the post(s) for which they are applying, as detailed in the CENs published on the official RRB websites. Candidates found medically unsuitable for the applied post(s) shall not be given any alternative appointment.

5.0 **Reservation and suitability for Persons with Benchmark Disabilities (PwBD):** These posts have not been identified as suitable for persons with disabilities.

10.0 **Examination Fee:**

NOTE: Only candidates who attend CBT will get a refund of their examination fee as mentioned above.

11.0 Candidates are required to go through the Post Parameter Table and Vacancy Table of detailed CEN No. RPF 01/2024 and CEN No. RPF 02/2024 to ascertain their eligibility before applying through ONLINE mode. Only one ONLINE application should be submitted by a candidate against each CEN separately i.e., **Only one application against CEN No. RPF 01/2024 and only one application against CEN No. RPF 02/2024.** Applications should be submitted only through any of the official RRB websites listed in Para 13 below. Any attempt to submit more than one application by a candidate against a CEN shall result in disqualification and debarment.

12.0 **Eligibility:** Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate does not satisfy the eligibility criteria for the post(s), his/her candidature will be rejected forthwith.
